I qualified as an Orthopaedic surgeon back in the year 2000 from Ahmedabad, India. I came to United Kingdom in 2003 and underwent specialist training within the field of spinal surgery. During my visits to home country, India, having been in touch with various colleagues and charity hospitals, I realized the need for specialist skills and overall support required within the field of spinal surgery for the care of under-privileged patients with spinal deformity.

The Spinal Care Foundation was set up to facilitate overseas surgical missions. The Spinal Care Foundation is on the UK register of charities and recognized by HMRC for the Gift Aid. We have organized following surgical missions and operated on 108 patients with spinal deformity.

The dates for the mission are set out well in advance approximately 3 to 6 months. The local hospital recruits the patients deemed suitable for the mission. The patients are triaged, investigated and prepared for the surgery.

The first day is generally a visit to the institute, introductions and settling in time for the visiting faculty. Approximately, 6-8 major and 3 to 4 minor operations are over a period of 1 week or so. A number of junior surgeons have benefitted from the education and knowledge sharing.
